「綠綠賞」轉「易賞錢」電子積分兌換合作試驗計劃

條款及細則:

「綠綠賞」電子積分計劃和「綠綠賞」手機應用程式(統稱為"綠綠賞")由香港特別行政區政府環境保護署管理和運營(在本條款和條件中稱為"綠綠賞")。易賞錢計劃("易賞錢")是由屈臣氏集團營運之客戶獎賞計劃(在本條款和條件中稱為"易賞錢")。

- 8. 如果易賞錢/綠綠賞用戶注意到或懷疑其積分被未經授權使用,他們應立即 以書面形式通知易賞錢/綠綠賞。

GREEN\$ x MoneyBack Point Conversion Pilot Collaboration Program

Terms and Conditions:

The "GREEN\$ Electronic Participation Incentive Scheme" and the "GREEN\$ Mobile App" (collectively, the "GREEN\$ ePIS") are managed and operated by the Environmental Protection Department of the Government of the Hong Kong Special Administrative Region ("GREEN\$" for the purpose of these terms and conditions). MoneyBack Program (the "MB Program") is a customer loyalty program managed and operated by the AS Watson Group ("MoneyBack" for the purpose of these terms and conditions).

- To be eligible for MoneyBack / GREEN\$ point conversion and redemption, members of the MB Program and GREEN\$ ePIS must register and link their MoneyBack and GREEN\$ ePIS accounts via the GREEN\$ Mobile App. Each GREEN\$ mobile app users can bind his/her account to one MoneyBack account only ("Account Binding").
- 2. Upon Account Binding, the GREEN\$ Mobile App users will be able to select GREEN\$ points for conversion into MoneyBack points. By agreeing to the Account Binding, the MB Program / GREEN\$ ePIS user is taken as having accepted these terms and conditions.
- 3. MB Program / GREEN\$ ePIS users who wish to modify their MoneyBack and GREEN\$ account linkage must first remove the existing linkage on GREEN\$ Mobile App before registering a new linkage.
- 4. Every 100 GREEN\$ points can be converted into 50 MoneyBack points, subject to the conversion rate determined by GREEN\$ and MoneyBack. GREEN\$ and MoneyBack reserve the right to modify the conversion rate at any time. Conversion / redemption is subject to the GREEN\$ points balance of the user account in GREEN\$ Mobile App. A request for conversion / redemption will be declined if there are inadequate GREEN\$ points to convert.
- 5. A maximum of 3,000 GREEN\$ points can be converted into MoneyBack points each month, equivalent to 1,500 MoneyBack points, subject to the conversion rate as determined by GREEN\$ and MoneyBack which may vary from time to time.

- 6. All point conversions are non-refundable, non-transferrable and irreversible once confirmed. MB Program / GREEN\$ ePIS users should check the redeemed points and other details of each conversion/redemption request carefully before sending and confirming the request. Points records of MoneyBack/GREEN\$ shall be final and no claim of points after the conversion/redemption will be accepted. Neither MoneyBack/GREEN\$ accepts any liability for loss due to technical or system issues.
- 7. MB Program / GREEN\$ ePIS users expressly consent to the transfer of their member ID and registered telephone number between MoneyBack and GREEN\$ for the purpose of MoneyBack / GREEN\$ point conversion and redemption. Each MoneyBack and GREEN\$ will use, handle and store the member ID and registered telephone number received and processed by it in accordance with their Privacy Policies and Personal Information Collection Statements, available on https://www.wastereduction.gov.hk/en-hk/resources-centre/green-mobile-app and https://www.moneyback.com.hk/setting/privacyPolicy.
- 8. If MB Program / GREEN\$ ePIS users notice or suspect that their points are being used without authorisation, they should inform MoneyBack/GREEN\$ in writing immediately.
- 9. MB Program and GREEN\$ ePIS are independently operated by their respective operators. The respective terms and conditions of the GREEN\$ ePIS and MB Program shall continue to apply. For information about the MB Program and GREEN\$ ePIS, please visit the official websites:
